Comrade SYTENKO Town of Rostov-on-Don

Responding to No. 0286/2 dated 24 April 1944, we are informing you that we have not located Joel Ajzikovich SHOJMER, Sara Borukhovna SHOJMER, and other relatives in Kremenets.

Upon questioning neighbors, it was found that they were sent to the Jewish ghetto in 1942 and did not return. At that time, the whole Jewish population of the ghetto was shot dead.

Responding to No. 02885 dated 24 April 1944, we are informing you that father Joel Ajzikovich SHOJMER, mother Sara Borukhovna VAJSBERG-SHOJMER, sister Lubov Jolyevna SHAPINKO-SHOJMER, residing at Krasnoarmejskaya Street, 180 / Delovoj dvor / and sister Liza Jolyevna SHOJMER-BEZNOSKO, residing at Potok-Irva Street, 13, currently do not live in the territory of the Kremenets district. Based on the account of witness Bronya VALBERG, it was found that they were taken by the "Gestapo" to the ghetto, and their later fate is unknown.

### DECLARATION

I am a native and permanent resident of the town of Kremenets, Tarnopol oblast, from which I was evacuated far inland on 28 June 1941, along with the staff of the Kremenets Municipal Department of the NKVD, where I worked as a secretary-typist. My family of 8 people:

- 1. Father—Joel Ajzikovich SHOJMER
- 2. Mother—Sara Borukhovna SHOJMER
- 3. Sister—Liza Jolyevna SHOJMER-BEZNOSKO
- 4. Sister—Lubov Jolyevna SHOJMER-SHAPINKO
- 5. Brother—Ajzik Jolyevich SHOJMER
- 6. First cousin—Ajzik Gedalyevich BEZNOSKO
- 7. First cousin—Motel Salomonovich SHAPINKO
- 8. First cousin—Perlya Ajzikovna BEZNOSKO

Did not have time to evacuate and remained under temporary German-fascist military occupation on the territory of the town of Kremenets, where they were shot dead by the Gestapo in May 1942, of which the Military Tribunal was informed by the Kremenets NKVD and NKGB.

In Kremenets, Krasnoarmejskaya Street, 176 and 180 / DYALOVOJ DVOR /, there are two onestory buildings and the belongings still preserved inside, which belonged to my parents—father I. A. SHOJMER, who worked as a bricklayer in Kremenets, and mother—S. B. SHOJMER—a housewife. Based on the information I have, these are still intact and, as the only heir, I have made many requests to the local administration—District soviet, District executive committee, asking to keep the houses and belonging for me, because, from the first days of WW2, and to this day, I have been working in the NKVD troops and am currently not able to come to Kremenets. However, I received no answer to any of my letters. There was an answer from the Kremenets District soviet dated 24 June 1945, but it did not touch on this matter. I am attaching a copy of this answer for your information.

I urgently ask that, upon receiving this, you direct the relevant administration services to keep the property mentioned above for me, until I return to Kremenets.

I urgently ask that you inform me of your decisions and their results.

I request that a certificate be delivered to me, confirming that my parents—father Iojlik Ajzikovich Shojmer, mother Sara Burukhovna, sister Leya Iolyevna Shojmer-Beznosko, sister Lubov Iolyevna Shojmer-Shapinko—were shot in 1942 in the Jewish ghetto by the German Gestapo. This certificate needs to be presented to the militia agency of the Ministry of Internal Affairs.

Comrade Z. I. Shojmer

The information you have from the civil registration office concerning the deaths of your relatives [illegible] confirm that your relatives [illegible] were abominably murdered by the German-fascist occupiers. The certificates you attached are official documents [illegible].
